## Frequently Asked Questions

### Who is eligible to enroll?

Single individuals, domestic partners, married couples and their dependents are eligible. Dependents are eligible up to 24 years of age (regardless of whether the dependent is attending school, living outside the parents' home, or married).

### What if I have another dental plan?

This plan cannot be used in combination with any other plan or offer. You may enroll and use this plan if you have reached your maximum coverage allowance with your current dental plan or when a procedure is not covered by your dental insurance.

### When does the plan go into effect?

Membership is immediate upon enrollment and is good for one year from that date.

\*In conjunction with another dental plan

\*For costs of dental care which are covered under workman's compensation

\*For treatment which, in sole opinion of the treating dentist, lies outside the realm of his/her capability

\*For referrals to specialists

\*For hospitalizations or hospital charges of any kind

\*For costs of dental care which are covered under automobile or medical insurance

\*For services which, in the opinion of the attending dentist, are neither necessary nor recommended for the patient's health

\*For general anesthesia

\*For services that cannot be performed because

of the general health, physical or psychological limitations of the patient

\*For oral health products or whitening products available for sale.

**No refunds will be issued at any time if participant decides not to utilize the dental plan.**
